SI. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 12 (total in Bal Vatika I, II & III). The total number of sections of the school from class I to XII shall be restricted to 43 of which not more than 1/3rd sections may be used for senior secondary classes. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. The maximum number of students in a section should not exceed 40
2	The ramps at the entrance do not have safety handrails in both sides. Hence, the school is directed to construct Ramp at entrance as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS with videography.
3	The school has converted regular cubicles into CWSN toilets, but they are narrow and there is no room for a wheelchair/walker to navigate. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.
4	Storage should be separate room or covered racks with restricted access instead of cabinets under work stations in Physics, Chemistry and Biology lab which constrain the movement of students and are unsafe. The school should replace plastic Chair used in the lab by wooden/metal stools. Safety features such as an Exhaust Fan, First Aid Kid etc are not available. The school shall upgrade the lab as per SoP issued by the board within 3 months and submit compliance on SARAS with videography.
5	Composite lab, mandatory for the secondary level is not seen in the video. The school must ensure of available of Composite Lab as per norms of the Board and submit compliance on SARAS with videography within 3 months.
6	Math lab is a temporary arrangement, with equipment is displayed on tables and no proper workstations / seating arrangements. The school shall upgrade the lab as per SoP issued by the board within 3months and submit compliance on SARAS with videography.

7	The Building Safety Certificates are not in prescribed format, the validity period, the number of blocks and floors are not mentioned in the Certificate. The number of floors is not mentioned in Fire Safety Certificate. Hence the school is directed to obtain fresh certificates (suggestive format is available with Circular no 12/2022) and upload the same on SARAS portal within 3 months.
8	The school has submitted Land certificate issued more than 1 years. Hence, the school is required to obtain a fresh land Certificate issued not more than 1 year as per the prescribed format (Appendix X of Affiliation Bye-Laws), upload the same on SARAS portal and submit compliance.
9	The school has not submitted the Water sample test report from Public Health Engineer Department. Hence, the school is required to obtain the same and upload on SARAS portal within 3 months.
10	School has constructed more classroom than permissible. Hence, the school is required to send an undertaking mentioning that the extra room will not be using for any academic and commercial activity and submit compliance on SARAS portal.
11	School shall ensure the mandatory training of its teachers from the CoE, CBSE Bengaluru within three months and shall upload the compliance on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.

- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
